Membership

Pool membership is open to all paid members of the NGC and their children up to twenty-two years old. All pool members including summer members must pay a fee of \$5.00 for any guest.

Summer Membership Costs:

Non-NGC family summer membership: \$200
Non-NGC individual summer membership: \$125
Non-NGC bed and breakfast summer membership: \$200

Responsibilities of all Pool Members

Must follow all rules posted at Ellicott Pool. They include:

1. No running
2. No horseplay
3. No diving in shallow end
4. No smoking
5. No glass in pool area
6. No alcoholic beverages allowed
7. No use of profanity
8. No children under 10 years old left without adult supervision. Any child over age 10 must be able to swim.
9. No food, drinks, gum, or coins allowed in the pool.
10. Lifeguards have ultimate authority regarding pool rules.

Members must register with the lifeguard and pay any fees before entering the pool.

Members must watch and supervise their children.
Parents of children five and under must accompany their children in the water.
An adult must accompany any child under ten years of age or a non-swimmer.
Members may not store personal items at the pool.
Food is allowed only in the picnic area, not under the pavilion.

Responsibilities of Lifeguards

The lifeguard has ultimate authority and may ask anyone misbehaving to leave the pool or the premises.

The lifeguard is paid to save lives and is not allowed to supervise, entertain, or babysit children.

Responsibilities of NGC

The NGC is not responsible for children who leave the pool or premises temporarily.

The NGC is not responsible for any lost or broken valuables left in the dressing room or the premises of the pool.

The NGC is not responsible for members or their children who break the rules.

The NGC reserves the right to close the pool if no lifeguard is available.

Parties at Ellicott Pool

Applications for all parties must be completed and pre-paid at the NGC office so a correct calendar can be kept. The appropriate number of lifeguards will be determined at the time of booking. All lifeguards will be provided by NGC.

After hours party fee is \$75.00 plus the lifeguard fee of \$10.00 per hour per lifeguard. For private parties, one lifeguard per twenty invited guests is required. Party time is from 7:00 - 10:00. According to Mississippi State Law, alcoholic beverages can be consumed in moderation by adults 21 years and older.

The party fee during pool hours is \$50.00 plus the lifeguard fee of \$10.00 per hour. The lifeguard on duty does not supervise party guests, therefore the host must pay for a party lifeguard, one for every twenty guests. The host and guests of any party must respect other members using the pool.
